Data Story Name: MICIP 2022-2025

Initial Data Analysis: The District Leadership Team, composed of the Superintendent, administrators from every building, and staff from every building as well as Central Office, compiled data time and time again unpacking the need for a K-12 data-driven system using non-academic and academic data to track the learning and performance of students and adults. Mancelona had some strong areas at various levels within the system and had research-based programming in language arts and math. However, tracking the learning and performance of students and adults in academics and non-academics lacked depth and breath of what was working and what was needed in the K-12 system. Since the pandemic and global unrest, the need to attend to a consistent, continuous, system wide approach to a K-12 data-driven system became very apparent.

Initial Initiative Inventory and Analysis: Some of our efforts have positive impacts in pockets of the system such as the elementary work in Reading Encore, an intervention, tracked by Aims web, M-Step, and NWEA data and observational data which demonstrated increasing students' confidence in at-risk classrooms at the elementary. Also, staff embracing and supporting children in and out of school during the pandemic tracked and provided food for all families with additional resources when needed. The training of some teachers in various subject and grade levels in our Otus platform have brought new learning to the building and supported some tracking of assessments. Pockets of teachers collaboratively working together have developed lessons aligned to the current curriculums and have identified some "look fors" in instructional pedagogy but these efforts were hard to track their efforts and outcomes. Coaches have been put in place to support math and language arts. We also require all teachers to place mandated assignments and announcements on our technology platform, Otus, which supported everyone during this pandemic. Currently Data Dashboard is used K-8 to review behavior trends and provide interventions while the high school used SWIS making it hard to see across the district of patterns, growth, and gaps in the system. There are also gaps between buildings (vertical and horizontal alignment) and need district-wide collaborative processes to look at the data.

Gap Analysis: We would like to see a K-12 alignment to make informed teaching and learning decisions to improve teacher effectiveness and student performance throughout

the system. At this time, we have begun tracking some common assessments from very few teachers and our data is not consistent to make informed decisions throughout. We currently have Otus to track common assessments but are in need to create a consistent, data-driven system tracking non-academic and academic data with interim, benchmark, and summative data measures consistently across the K-12 system.

District Data Story Summary: More than 90% of the students at Mancelona Public School are white and about 75% of students receive free or reduced lunches. Free breakfast and lunch are offered to all students at Mancelona Public Schools. In 2021-2022 almost half of all students were considered chronically absent, which means that students were absent 10% or more of the school year. Prior to COVID, this percentage was below 20. Attendance will continue to be a major priority at MPS! According to State tests of achievement, in general, students are less proficient than State averages in reading, math, science, and social studies with the greatest rates of success at Mancelona Middle School. There are some exceptions to this generalization and all teachers and administrators are working to improve our proficiency rates.

As we have summarized our work, a K-12 system that drives people, products, and processes embedded in the leadership, competency, and organization drivers to track the learning and performance of students/adults in order to determine what is effective and what is not currently working in our system. However, to unpack this we have to develop our staff, the products we implement, and create processes K-12 to support this complex initiative.
