Mrs. Grabruck invited the Board members to attend the formal expansion of CIS announcement being held on October 26, 2017 at the Helena Township Hall from 6:00 pm to 8 pm. Mrs. Grabruck also stated that the mentoring program is up and running however the program is in need of men mentors for the middle school students.

Principal Report — Tina Frollo stated the elementary school carnival was a success and that the profits will go towards Young Authors. Mrs. Frollo stated the new teachers had their review of Marzano so they have knowledge of the teacher evaluation program. Mrs. Frollo announced that field trips have already begun with trips to Hoxsie Farms, Grass River and Fire Prevention. Mrs. Frotlo stated due to the new 3rd grade reading law change, the parent teacher conferences have been moved earlier in the year, being held October 24th and October 26th from 5:00 to 8:00. Mrs. Frollo stated she will be sending out fliers for the conference change, a letter to the parents regarding the new reading law and information on how the parents can help their student at home. Mrs. Frollo announced that the Jog-A-Thon will be held in the spring. Larry Rager stated the first round of testing is complete in the middle school. Mr. Rager announced that October is reading month with All Hallow's Eve event organized by Joleen McCain. Mr. Rager stated that Shawn Fustini was the first recipient of the \$25.00 attendance incentive reward. Mr. Rager indicated that enrollment is up with 3 more students being enrolled 10/11/17. Mr. Rager stated it is fun to see students excited about education. Trent Naumcheff stated that Mr. Tony Cutler with student council, has been involved and directing many of the Spirit Week events. Mr. Naumcheff announced the homecoming dance will be held Saturday, October 14th• The high school marching band performed at Thirlby Field on Monday, October 9th. Mr. Nacumcheff reviewed the changes and edits in the high school handbook. Mr. Naumcheff indicated he will be communicating the changes and edits at parent teacher conferences as well as distributing handouts. Mr. Nauncheff also announced the 2nd annual College Fair being held at the high school October 11, 2017 beginning at 9:30 a.m.

Superintendent's Report- Mr. DiRosa encouraged attending the College Fair Wednesday, October 11, 2017 as it was a great event last year. Mr. DiRosa acknowledged that Tina has been getting ready for the Title I audit that will take place on 12/18/2017, the week of Christmas break. Mr. DiRosa stated student count is 980. Kim Musselman asked what we budgeted for, Mr. DiRosa responded 945 with a deficit.

Technology Update: Bryce Kennedy stated that at this time all teachers have received pointers. Mr. Kennedy indicated the elementary school received 23 new projectors and the middle school received a new bell and paging system, Mr. Kennedy announced that the wireless coverage has been expanded and 70 desktop computers have been replaced. Mr. Kennedy also indicated that we have purchased 350 Chromebooks. Mr. Kennedy stated that over Christmas break, upgrades to our network will take place.
